# **Inspection Description:**

This is a North Lake Tahoe Fire Protection District permit to conduct seasonal open burning. Permit must be available on site for inspection. Permit is only valid for one season and only for the address listed above. Open burning is prohibited on No Burn Days. Please visit NLTFPD.ORG to determine burn day status and to verify when burn season has ended. Slash/Needle pile burning is permissible from 6:00am-3:00pm. Piles must be extinguished by 3:00pm. Recreational fires must be extinguished by 9:00pm. Open burning must be constantly attended by a responsible adult.

## Inspection Topics:

### **Slash/Needle Pile Requirements**

Slash piles shall be at least 50' away from structures. Pine needle piles shall be at least 25' from structures. Slash piles shall not be larger than 5' in height and 5' in diameter. Pine needle piles shall not be larger than 2' in height and 3' in diameter. Piles must have a 2' non-combustible zone (bare soil) around piles. Piles must be at least 30' from combustible materials (storage) and vegetation (brush, tree canopies, etc.).

Tools and a charged water hose from a bib to extinguish a fire must be readily available during burning. Burn area must be watered prior to any burning if snow is not on the ground. The use of an accelerant is prohibited. Burn piles must be burned one at a time. Piles can ONLY be ignited from the top of the pile.

### Recreational Fire Requirements

Recreational fires must be contained within a non-combustible container and covered with a 1/8" mesh. Recreational fires cannot be located on or under balconies, decks, patio covers or within 30' of any structure. Only clean wood may be burned. No debris or hazardous materials may be burned. The fire must be extinguished by 9:00 p.m. every evening, or when no longer constantly attended.

## **Closing Notes:**

Every person who willfully or negligently sets or fails to guard carefully or extinguish any fire, whether on the person's own land or the land of another, whereby the timber or property of another is endangered is guilty of a misdemeanor (NRS 475.010). Every person who, with gross negligence, lights a fire for any purpose along the road through any woodland, or upon the same, or at any other place in the open, and thereby, or by any other means, sets fire to any growing timber or forest, shrubbery, crops, grass or vegetation, and thereby causes the destruction of any timber, forest, crops, grass, vegetation or property not his or her own, is guilty of a public offense, as prescribed in NRS 193.155, proportionate to the value of the loss resulting therefrom, in addition to being liable to the owner of such property for the full value thereof in a civil action (NRS 475.040). Each fire department may investigate: the cause, origin and orcumstances of each fire which occurs within its jurisdiction and which results in the destruction of or damage to property, loss of life, or injury to any person; any report received pursuant to NRS 629.045 to determine the origin of the fire which caused the injury (NRS 475.125). It is unlawful for any person willfully or negligently: to throw or place any lighted cigarette, cigar, ashes, match or other material which may cause a fire in any place where such lighted cigarette, cigar, match, ashes or other material may start a fire (NRS 475.030).
